Assisted suicide is legal in the U.S. for residents of Washington, Oregon and Montana; and for citizens of Switzerland, Belgium, Netherlands and Luxembourg (where euthanasia is also legal). In physician-assisted suicide, the physician writes the prescription for the lethal medication, but the patient administers it.
