### **Texas Motor Vehicle Tax Forms**

A motor vehicle purchased in Texas to be leased is subject to motor vehicle sales tax. The lessor is responsible for the tax, and it is paid when the vehicle is registered at

the local county tax assessor-collector's office. The lease contract is not subject to tax.

## **Motor Vehicle Taxes Frequently Asked Questions**

Texans who buy a used vehicle from anyone other than a licensed vehicle dealer are required to pay motor vehicle sales tax of 6.25 percent on the purchase price or

standard presumptive value (SPV), whichever is the highest value. SPV applies wherever you buy the vehicle, in Texas or out of state. A vehicle's SPV is its worth based on similar sales in the Texas region.
